The Chairperson shall, at the AGM allow voting by use of e-voting system for all those Members who are present during the AGM but have not cast their votes by availing the remote e-voting facility before the AGM. The e-voting module during the AGM shall be disabled by NSDL for voting 30 minutes after the conclusion of the Meeting.

INSTRUCTIONS FOR MEMBERS FOR REMOTE E-VOTING ARE AS UNDER:

- (i) The voting period begins on Thursday, the 25th day September, 2025 from 9.00 a.m. and ends on Monday, the 29th day of September, 2025 at 5.00 pm. During this period Members' may cast their vote electronically. The e-voting module shall be disabled by NSDL for voting thereafter. The e-voting will again be enabled for 30 minutes after conclusion of the AGM.
- (ii) In accordance with the provisions of Section 108 and other applicable provisions, if any, of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and amendments thereto, the Company has engaged the services of National Securities Depository Services (India) Limited ("NSDL") to provide the facility of voting through electronic means to the members to enable them to cast their votes electronically in respect of all the businesses to be transacted at the aforesaid Meeting.
- (iii) The Company has appointed Mr. Pratik M. Shah, Practicing Company Secretaries (Membership No. F7431) as the Scrutinizer for scrutinizing the entire e-voting process i.e., remote e-voting, physical voting at the AGM and e-voting for 30 minutes after conclusion of the AGM to ensure that the process is carried out in a fair and transparent manner.
- (iv) Members attending the AGM physically should note that those who are entitled to vote, but have not exercised their right to vote by remote e-voting may vote through e-voting during the 30 minutes after conclusion of the AGM for all businesses specified in the Notice. The Members who have exercised their right to vote by remote e-voting may attend the AGM, but cannot vote during the AGM or during the 30 minutes after conclusion of the AGM. The Chairperson shall, at the AGM, at the end of discussion on the resolutions on which voting is to be held, allow voting with the assistance of scrutinizer, by use of ballot paper for all those members

who are present at the AGM but have not cast their votes by availing the remote e-voting facility.

- (v) The Scrutinizer shall after the conclusion of voting at the general meeting, first count the votes cast at the meeting by ballot and thereafter unblock the votes cast through remote e-voting in the presence of at least two witnesses not in the employment of the Company and shall make, not later than three days of the conclusion of the AGM, a consolidated scrutinizer's report of the total votes cast in favour or against, if any, to the Chairperson or a person authorized by him in writing, who shall countersign the same and declare the result of the voting forthwith.
- (vi) Voting rights of the members (for voting through remote e-voting) shall be one member - one vote as on the cut-off date i.e. 29th September, 2025.
- (vii) A Member can opt for only one mode of voting i.e., either through Remote e-voting or through ballot paper at the AGM. If a member cast votes by both modes, then voting done through Remote e-voting shall prevail.
- (viii) The remote e-voting period begins on Thursday, 25th September, 2025 (9.00 a.m. onwards) and ends on Monday, 29th September, 2025 (up to 5.00 p.m.). The remote e-voting module shall be disabled by NSDL for voting thereafter i.e., beyond 5:00 p.m. of Monday, 29th September, 2025. Procedure for remote e-voting and e-voting during the 30 minutes after conclusion of the AGM

- i. The voting period begins on Thursday, 25th September, 2025 (9.00 a.m. onwards) and ends on Monday, 29th September, 2025 (up to 5.00 p.m.). The e-voting module shall be disabled for voting thereafter. It shall be again enabled for 30 minutes after conclusion of the meeting.
- ii. Voters should log on to the e-voting website **www.evotingindia.nsdl.com** during the voting period.
- iii. Click on Shareholders/Members.
- iv. Enter your User ID as sent by NSDL.
- v. Next enter the Image Verification as displayed and Click on Login.
- vi. Enter your password as sent by NSDL.
- vii. After entering these details appropriately, click on “SUBMIT” tab.

Select the EVEN of “Bombay Incorporated Law Society” on which you choose to vote.

- viii. On the voting page, you will see “RESOLUTION DESCRIPTION” and against the same the option “YES/NO” for voting. Select the option YES or NO as desired. The option YES implies that you assent to the Resolution and option NO implies that you dissent to the Resolution.
